## **Conditions for Clubhouse Usage (<u>Return with Usage Agreement</u>)**

- 1. Member must be in good standing and must attend the event
- 2. Rental Fee and Security Deposit must be paid in advance.
- 3. The Deposit will be RETAINED IF CLUBHOUSE IS NOT CLEANED or any of the following conditions are not complied with. If clean-up costs or damages exceed the amount of the deposit, the resident who reserved the clubhouse SHALL BE LIABLE FOR ADDITIONAL CHARGES
- 4. The key may be picked up the last business day preceding the event.
- 5. A walk-through must be performed prior to use with the Manager or a Board representative.
- 6. Noise must be kept within the confines of the facility.
- 7. No birdseed, rice, glitter, or other confetti may be thrown.
- 8. DO NOT SLIDE FURNITURE.
- 9. Furniture must be returned to its original position or DEPOSIT WILL BE FORFEITED.
- 10. Abrasive tape or tacks may not be used on walls, ceilings, or fireplace.
- 11. Office furniture and other accessories shall not be moved or rearranged.
- 12. The member is fully responsible at all times for their guests and the condition of the facility.
- 13. POOL PARTIES ARE NOT ALLOWED. Access to the back door is for emergency only.

## **REOUIREMENTS INCLUDE, WITHOUT LIMITATION, THE FOLLOWING:**
